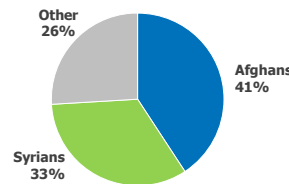

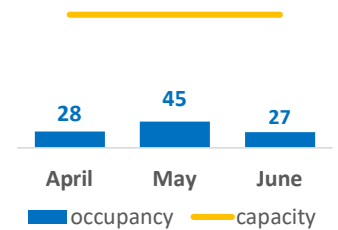
Current age and

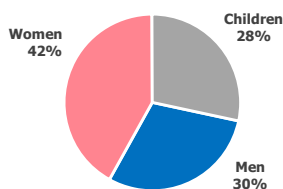

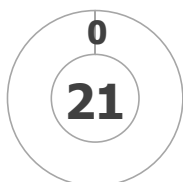

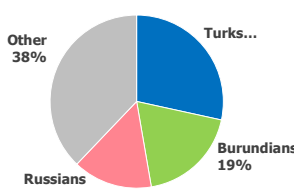

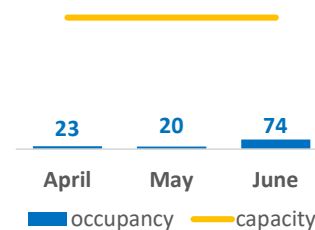
Current age and gender breakdown

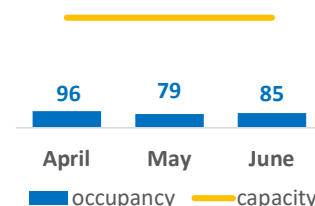
Current age and

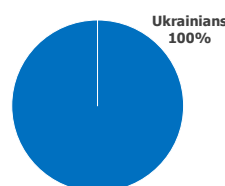

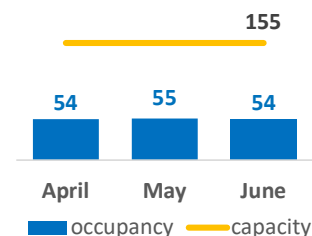
**Current age and
